



Dear Logos Academy Harrisburg Families,

Please read, sign, and return the following document:

We know that the transition to online learning in Spring 2020 resulted in a learning curve for everyone. We've had to adapt to using new tools for education. All technology comes with some benefits and some costs. Right now, these tools are helping us continue to educate your child. But without proper use and limits, these devices and online tools can be overwhelming. To be responsible for our students as we move into this online learning environment, we must inform you of the legal requirements that are in place for student protection.

Logos Academy Harrisburg (LAH) facilitates online video classes that are recorded, so that students can view and review content delivered by teachers. Additionally, LAH provides students with access to some of the most effective web-based tools and educational applications available for learning. Many of these tools, like Seesaw and Zoom, are not operated by LAH, but by third parties.

The **Children's Online Privacy Protection Act (COPPA)**, a federal law, requires parental notification and consent for student use of school-approved online resources for instructional purposes. (For more information on COPPA, please visit <http://goo.gl/sNf9ly>.) But instead of having every web site and online service contact you personally, the law permits schools to act as the parent's agent and can consent to the collection of student information on the parent's behalf *with parent permission*. In order for our students to use these online resources, certain student information might be requested by the service provider (typically a student name, password, username, or email address.)

A complete list of the programs with the privacy policy and terms of service for each can be found below. By contract, these vendors have agreed to protect student privacy and adhere to COPPA regulations.
